## WHEN MAY HOLDING FUNDS IN TRUST BE BENEFICIAL?

### ■ The person intended to benefit from the funds:

- *Has an illness or condition which precludes developing the skills necessary for money management;*
- *Has an illness or trait which makes them particularly vulnerable and subject to exploitation*
- *Is in a relationship with an exploiter, abuser, spendthrift or addict*
- *Has not reached the age of majority*
- *May need to access public benefits including Supplemental Security Income and Medicaid, which limit assets to \$2,000*
