

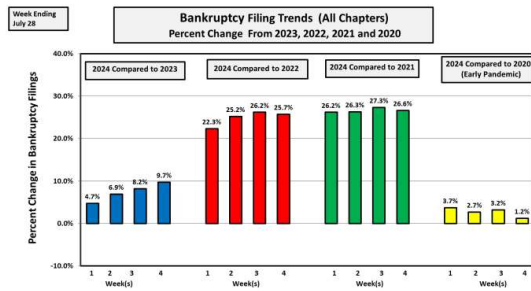

- SubV filings saw a 61% increase from 2023.

Nearly a third of bankruptcies this year have come from consumer discretionary sector as retailers come under pressure

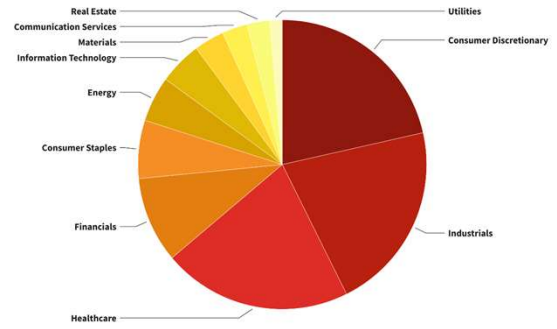
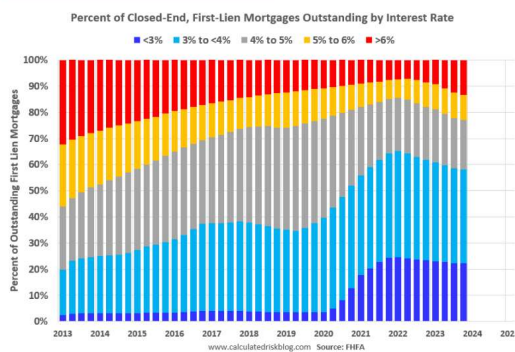

Real Estate Filings Expected to Continue Rising

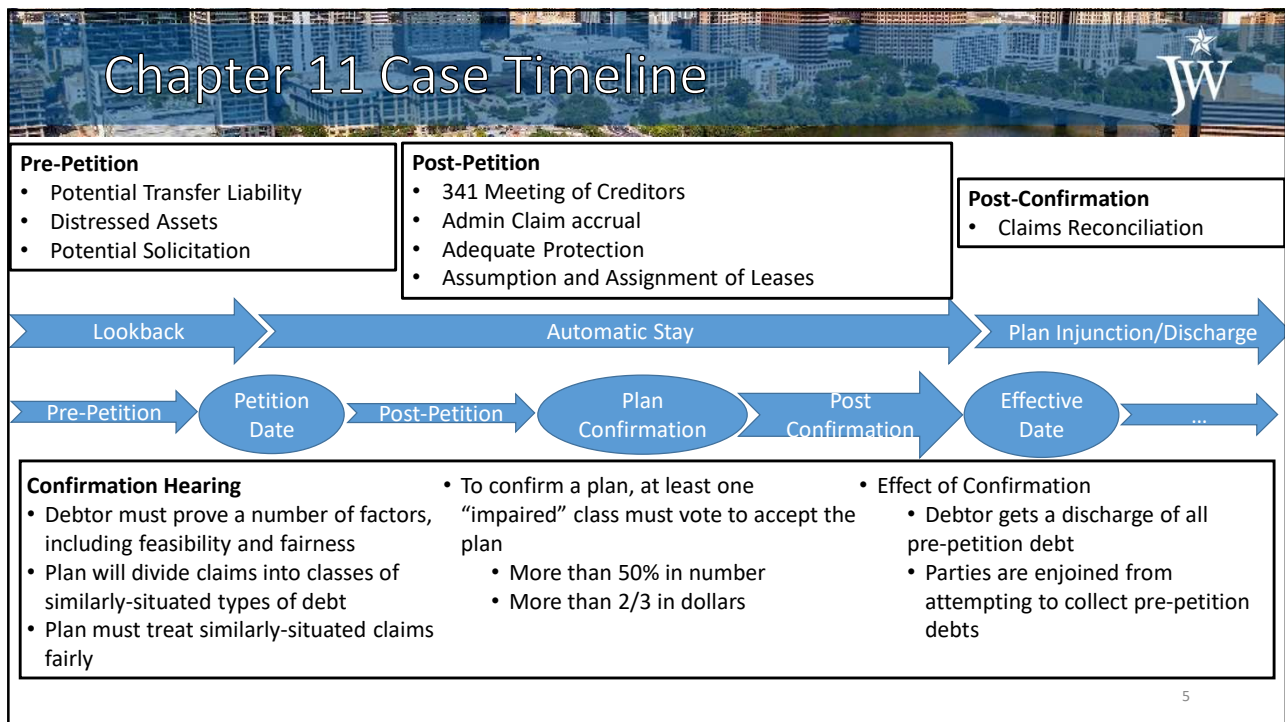


Distress by property type

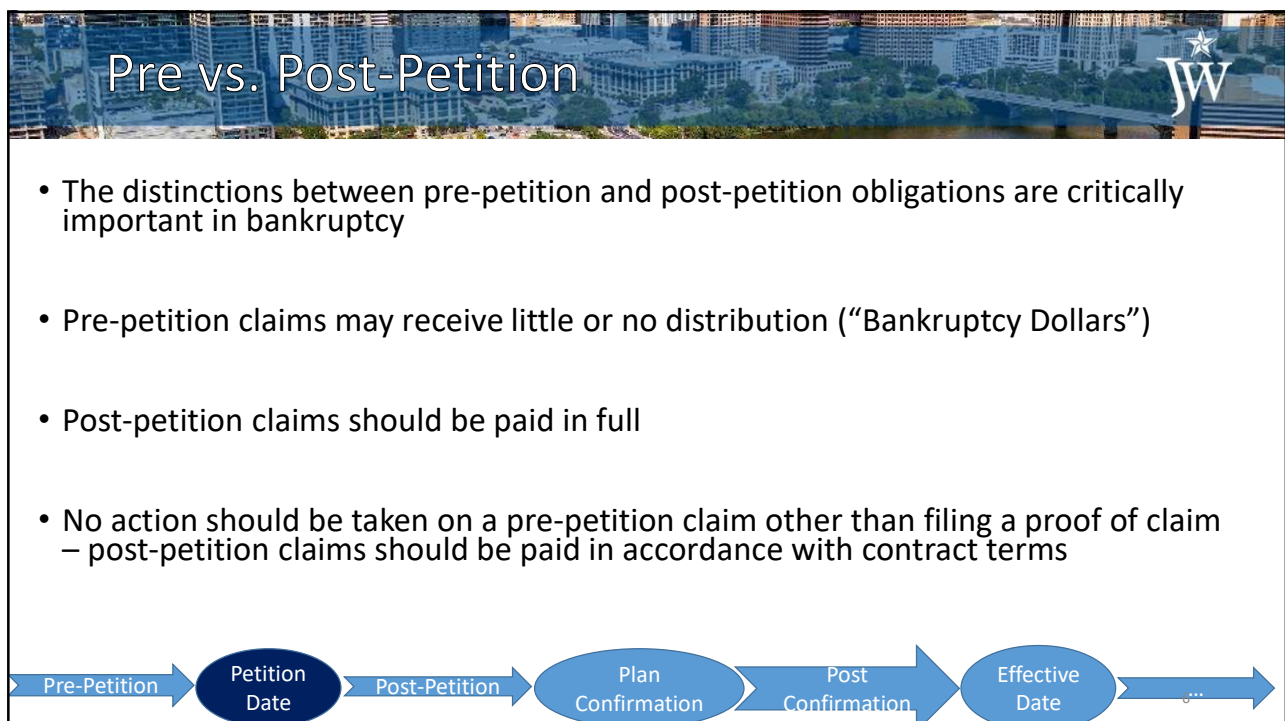
